Administrative Report - Karin Hilgersom, TMCC President

The SBBC Salary Enhancement proposed language is being presented to the necessary shared governance committees in order to bring to fruition as quickly as possible.

COLA funding was confirmed, TMCC will receive \$3.2M in COLA Funding representing 72% which is state-funded.

The Panasonic TMCC Partnership has opened the new facility on Plumb Lane.

H.R.6655-A Stronger Workforce for America Act passed the House of Representatives 378/26 and is headed to the Senate. The bill focuses on skilling and reskilling of workers. This bill will benefit community colleges.

Administrative Report – Jeffrey Alexander, Vice President of Academic Affairs

The credit for prior learning teams continue their work. Their next meeting is April 26.

The tenure binder process for digital submission has been tested and the VPAA's office continues to work with WebServices to find the best software for digital submissions and signature routing.

Part-Time Faculty Committee - Edwin Lyngar

The committee met today. Edwin presented the Part-Time 1 & 2 Program for a second read.

Motion: Tara Connolly moved and Jon Lau seconded to approve the Part-Time 1 & 2 Program. The motion passed unanimously.

Professional Standards Committee - Karen Wikander

Karen brought two forms and a document for action today: Annual Performance Evaluation for Librarians, Observation of Library Instruction, and the Summary of Tenure Related Activities for Librarians. Karen reviewed the changes made to the forms.

Motion: Staci Miller moved and Tara Connolly seconded to approve the Annual Performance Evaluation for Librarians form, Observation of Library Instruction form, and the Summary of Tenure Related Activities for Librarians document. The motion passed unanimously.

Karen also noted the committee will be working on the Student Evaluation Form and the annual forms for counselors next year. Senator Jensen commented about administrative rights on office computers. The committee next meets April 26, 2024.

Recognition and Activities - Tara Connolly

The Share the Love event wrapped up. The seed sheets will be donated to the Pollinator Garden. Career Champions nominations will open soon. The February, March, and April Professionals of the Month will be awarded soon. The committee received approval for a co-chair leadership. The committee next meets May 7, 2024.

Salary, Benefits and Budget Committee - Bradley Summerhill

SBBC passed a modified salary enhancement resolution. Cabinet has already approved the resolution with a wording change. There is really no need for action today.

Note bene: Ideally, this policy will never be enacted, I.e. we will receive state and Board approved COLA instead.

This internal salary enhancement policy and procedure is unprecedented in the history of this college. It is necessary, as the president noted. It is sustainable, as the VPFG confirms. It will, as the president also rightly notes, help stabilize salaries for the TMCC workforce in an ongoing effort to offer a salary matrix of policies and solutions that will denecessitate our unhealthy reliance on equity studies.

Senator Jensen moved to approve the document with a change to strike the second sentence of the first paragraph. Due to lack of a second, the motion died.

Motion: Senator Martha Johnson-Olin moved and Senator Joe Sanpietro seconded to approve the TMCC Internal Salary Enhancement Policy. The motion passed unanimously.

WebCollege Faculty Advisory Committee - Frank Amankonah

The committee met prior to today's Faculty Senate Meeting. The committee had a demonstration for Honorlock which may replace Proctor U. The committee discussed the role of the Retention Specialist and John Hughes will assist in revising the email sent to students by the specialist to avoid student confusion. The Testing Center is taking a head count to find out how many students will be coming during finals. The due date of April 12 is for count purposes. Instructors can submit tests when they are ready. The committee also discussed revising the Optional Self-Evaluation to the Annual Plan for clarity.
