# Past Chair's Report - Rick Bullis

An anti-discrimination policy was passed at the June 2024 Board of Regents (BOR) meeting. The regents heard the results of a climate survey on violence on campuses. Rick noted there was a small sample size and the data combined the community colleges with the universities.

# Chair's Report - Jinger Doe

**Board of Regents Meetings:** On July 11 the BOR heard a presentation from the National Institute for Student Success (NISS) on data collected and strategies to increase historically underrepresented group achievement. This data is at no cost to Hispanic Serving Institutions. A code revision for presidential vacancies was presented as an informational item. The BOR also had a presentation from the National Alliance of Concurrent Enrollment Partnerships (NACEP). Their standards align with our accrediting body.

On July 25, a 75-10-15 split was approved at the ad hoc meeting for the Higher Ed Funding Formula for recommendation to the full board.

On August 23, the code revision for a vacating president passed. A recent expansion of Title IX was explained by an NSHE Human Resources representative. The 2025-2027 Biennial Budget requests were discussed. Currently, COLA's funded at 80% seem to have support from the Governor's Finance Office, but is not a done deal at this time. The 75-10-15 split was approved at the special meeting with a provision to hold harmless UNR and UNLV. This was an agenda item for action on the September 5-6 meeting. The Council of Chairs will draft a letter to be read during public comment requesting respectful dialog from the regents when discussing the LGBTQ+ community. The chancellor search continues and a search firm has yet to be finalized. The TMCC Presidential Search Listening Session is on Sept. 27 and will be facilitated by Chancellor Charlton, Chair Carvalho, and Vice-Chair Downs. Faculty Senate's allotted time is at 9 a.m. Chancellor Charlton will attend the February 2025 Faculty Senate meeting to present NSHE -wide concerns for the legislative session.

The September 5-6, 2024 Board of Regents Meeting highlights included the BAS in Applied Business Management being approved. The funding formula with a hold harmless for UNLV and UNR was approved by the full board. New business requests made were DEI and Anti Bias Training for the regents, a post-tenure review process, a policy for termination of academic faculty, and sunsetting the IDEA committee. Jinger and the other Senate Chairs will be monitoring these suggested new business items for possible public comment.

# Chair Elect's Report - Joe Sanpietro

September 17 is TMCC Sprit Day in the Plaza. Upcoming events include a play in November titled Nearly Washington, a faculty and student art show, gallery exhibitions, and the Art Fest in Spring 2025. A faculty member is needed for a tenure track committee, please reach out to Dean Julie Ellsworth if interested in serving.

# Administrative Report – Karin Hilgersom, TMCC President

Dr. Hilgersom opened her report thanking the emergency personnel and employees at the Redfield Campus for their efforts during the fire.

Dr. Hilgersom provided a history of the co-requisite model and policy implementation. She offered to visit the English and Math departments for a check-in as well as the other departments. The supporting materials for the corequisite model can be found on the NSHE website archives (June 2019 meeting). The policy is found in the NSHE Handbook under Title 4.

# Executive Director Research, Marketing and Web Services - Kylie Rowe

Kylie introduced herself and updated the Senate on the activities in the departments she oversees. Institutional Research is creating a projection model to show what programs and services increase the likelihood of retention. Marketing and communications are ready to help with project requests. WebServices performed a web refresh to the website.

# Administrative Report - Jeffrey Alexander, Vice President of Academic Affairs

Dr. Alexander provided a pre-recorded video of his report and Dean Natalie Russell attended to answer any questions.

Items in Dr. Alexander's report were the approval of the BAS in Business Management at the September BOR Meeting, the credit by portfolio process launching with a webpage for interested students, and Honorlock will be available as an additional proctoring tool.

Dr. Alexander noted Honorlock was added for distance learners residing both outside of Washoe County and Nevada, compliance with our accrediting body, and for future expected compliance with the federal Department of Education. There is no charge to students using Honorlock. Proctor U and Respondus will remain available.

# Budget Update - Vice president of Finance and Government Relations - Mike Peyerl

The senate received updates on FY 24 closing, FY 25 overview; FY 26 and 27 biennium budget build update, and a government relations update for federal and state levels. Mike noted the biennium budget build is a request and will need to go through the Governor's recommendation and legislative actions.

Currently merit is available. The BOR could vote to suspend it at a later date though.

The committee is ready to work with administration on implementing the PT Level I & II program. The committee will also fine-tune the part-time faculty directory and create a benefits available webpage. The committee next meets October 11, 2024.
