# Chair's Report - Jinger Doe

The Presidential Search Committee will be convening soon, five volunteer faculty members, nominated by Faculty Senate are needed. The Salary, Benefits and Budget Committee and the Professional Standards Committee will work together in a joint subcommittee to work on merit. The Board of Regents are proposing some policy changes. Jinger will send out the proposed changes on Monday. The Planning Council is proposing a policy for student identification in distance education courses. Jinger requested any feedback on the proposed NSHE Code changes and any further concerns about the proposed policy.

# Chair Elect's Report – Joe Sanpietro

Chair Elect Joe Sanpietro noted the upcoming holidays of Veteran's Day and Thanksgiving. He also provided an overview of events and good things at TMCC such as innovation grants, Library After Dark, Fall Dance Concert, an upcoming play, and donations for pets, and the Adopt a Family Event.

# Past-Chair's Report - Rick Bullis

Past Chair Bullis did not have anything to report.

# Administrative Report - Karin Hilgersom, TMCC President

Dr. Hilgersom reported on the First-Generation Student Panel, the Veteran's Resource Center opening, and the Rotary Peace Pole dedication. She also gave an overview of the Joint Executive Board (JEB) and its work to proactively resolve issues and concerns.

Cost estimates needed to build Phase 1 of Eastview are ready for BOR approval at an upcoming meeting. The facility will include a small theater, construction space, and three classrooms for a temporary home for the TMCC Architecture program. If and when funds are obtained for a shared facility with DRI and NSU, a permanent home for Architecture would be included in that new facility (TMCC is the only community college in the country to offer a Bachelor Degree in Architecture). The cost estimate came in at 15.8 million, and costs were lowered because some elements of the building are pre-fabricated. The building will be located near the wind turbines and will be debt free due to smart savings over several years, including interest earned on NSHE released investment pool dollars and a million dollars earmarked for EastView planning. Private donor fundraising will also happen to enhance the building.

# Administrative Report – Jeffrey Alexander, Vice President of Academic Affairs

Dr. Alexander reported the first Credit for Prior Learning (CPL) student has come forward with their portfolio in Accounting. The system office has asked TMCC to update our NSHE Planning Report. Goals TMCC is adding to the report are to seek BAS in Elementary Education, a Certificate in Physical Therapy, and a degree program in the future.

Dr. Alexander met with faculty prior to today's meeting to discuss a solution to student online verification. A single Canvas shell was proposed where students would be placed as they enroll in online classes. A pilot will be developed for the Spring Semester.

## Academic Standards and Assessment Committee - Martha Johnson-Olin

The committee has not met since the last Faculty Senate Meeting. The committee next meets November 15, 2024.

### Administrative Faculty Committee - Katie Paul

The committee met on October 18 and chose to table merit until Fall 2025. They continue working on Administrative Reclassification. The committee also expressed a desire to have TMCC as a voting station. The committee next meets November 15, 2024.

#### Curriculum Review Committee - Stephanie Mead

The committee met November 1, 2024 and discussed workflow process along with their rigorous agenda for courses and programs. The committee next meets December 6, 2024.

## Learning Commons Committee - Fred Lokken

No report was given.

## Part-Time Faculty Committee - Matt van den Berg

The committee met this morning. They discussed verification for online students, the Part-Time 1 and 2 project, the part-time directory, and will be working on an emeritus-type of procedure for retiring long-time part-time faculty. The committee next meets December 13, 2024.

#### Professional Standards Committee - Karen Wikander

Karen brought two forms for approval: Observation of Counseling Effectiveness and Annual Performance Evaluation for Academic Faculty (Counselors). Karen gave an overview of the changes on each form with the Senate body and requested a vote to approve each form separately. These forms came to the Senate from the Professional Standards Committee.

Motion: To approve the Observation of Counseling Effectiveness form. The motion passed.

Motion: To approve the Annual Performance Evaluation for Academic Faculty (Counselors). The motion passed.

Karen reported another form for librarians will come to the Faculty Senate soon. The committee will review the merit bylaw, review online and in person observation forms, and student evaluations. The committee next meets January 31, 2025.

## Recognition and Activities - Olga Katkova

The committee has not met since the last Faculty Senate Meeting. Olga introduced the bylaw change second read to include Career Champions in the committee's charges and asked for a vote.

**Motion:** To approve the bylaw change to the charges for the Recognition and Activities Committee: "5. For Career Champions Award: solicit nominations from students for a once-a-semester recognition, review candidates through human resources, arrange presentation of the award to the recipients, and email certificates and details of the nomination(s) to each recipient." The Faculty Senate approved the change.

Olga also asked to please also nominate academic faculty for the Professional of the Month. The committee next meets November 13, 2024.

# Salary, Benefits and Budget Committee - Bradley Summerhill

Merit discussion is continuing and the committee may have something to present to Faculty Senate in December. The committee next meets November 15, 2024.

#### WebCollege Faculty Advisory Committee - Frank Amankonah

A subcommittee will be convening to align the new QM Rubric with online teaching standards. Frank brought a motion from the committee to be approved at Senate. Elyssia Fraga also gave a demonstration of the features listed in the motion.

**Original Motion:** To turn on Discussion Summary and Rubric Enhancement/Design features in Canvas now. The Senate proposed wording changes to the motion for clarity.

**Amendment to the Motion:** To turn on Discussion Summary and Rubric Enhancement/Design features in Canvas at this time; these features would be off by default and require individual faculty to turn them on in their course. The motion passed.

#### Classified Council - Jen Friend

The Classified Council is getting ready for the Holiday Party, the ham/turkey raffle, and the basket silent auction.

## Student Government Association (SGA) - Lisha Allison
